

ADEC Support at Home Fees

Introduction

As a registered charity, ADEC does not seek to make profits from the services we provide. As such, our fees are based solely on what we have identified it will cost to provide your services. ADEC has set our fees based on either support worker salaries set by the relevant industry award or what your providers charge us to deliver each service, and also the cost to ADEC to administer, manage, quality check and coordinate these services.

As the Support at Home program is new, ADEC will monitor and regularly review the cost of services we provide to you under your Support at Home package. Through working with preferred providers, reducing the number of providers we engage to provide your services, and employing our own staff to deliver services where we can, ADEC expects to provide more competitive pricing in future, helping you to increase the supports you can receive.

Most services are provided Monday to Friday, excluding Public Holidays. Independence Supports can be provided as per your assessment and preferences; however, increased costs and contributions will be incurred after hours and on weekends. Daily living supports are only provided from 7:00AM to 7:00PM. Clinical supports, apart from Nursing Care are generally provided on weekdays between 8:00 am and 5:00 pm only and are not provided on Public Holidays. Your service types and times will be based on your needs and your package level in consultation with you and your Clinical Care Partner.

Service Terms

1. The full cost of the scheduled service will be charged if cancellation is received within 24 hours of or after 12:00PM on the day prior to the service.
2. Accompanied (direct) transport fees apply if the Support Worker is required to use their private car for the service.
3. Independence and Daily Living services are provided as a minimum 2 hour engagement, unless otherwise agreed.
4. Overnight Care includes overnight respite or companionship and may include a "sleepover shift", during which the worker may sleep unless needed by the client, or a "companion shift", during which the worker is awake throughout the night. Sleepover shifts are charged at a lower rate.
